



**Safe Reopening Plan & Procedures  
Fall 2020**



---

*St. George Greek Preschool holds the health and safety of students and staff as an utmost priority. Therefore, the following measures will be implemented for the 2020-2021 school year:*

---

### *Enrollment Requirements*

- Children entering the program for the first time or re-enrolling must have immunization records which meet the guidelines of the Maryland Department of Health.
- Each child must have at least one dose of each vaccine appropriate for the child's age and a schedule to complete required immunizations.

### *Ensuring Social Distancing*

- Classes include the same group of children each day with no mixing, or very minimal mixing, between groups.
- Keeping children in small groups.
- Low Student-Teacher ratio.

<b>Class</b>	<b>Ratio</b>
2 years	8:1
3 years	10:1
4-5 years	12:1

- No large group activities, assemblies, gatherings.
- Students will primarily be seated in individual student desks.
- Space out seating and bedding (head-to-toe positioning).
- Staggered recess time.
- Staggered gym time.
- More outdoor classes when practical.
- Snack and lunch breaks will occur in student classroom.
- Restricting outside visitors and volunteers.
- Drop-off/Pick-up procedures:
  - Parent/Guardian to pull up to the circle and be greeted by a staff member who will conduct a brief health screening and take the child's temperature using a contactless thermometer.
  - Parent/guardian to not leave their vehicle or enter the educational building.



### Promoting Healthy Hygiene

- Staff will be educated on how to monitor for symptoms and stay home if they are sick.
- Instructing parents/guardians to keep children home if they or any member of the household exhibits symptoms.
- Persons who have a fever of 100.4 (38.00C) or above or other signs of illness will not be admitted to the facility.
- Establish routine, daily symptom screening and temperature checks on arrival, for both staff and children.
- Teach and reinforce washing hands frequently.
- Teach and reinforce use of cloth face coverings and/or face shields among all staff and children when feasible. Face coverings are most essential at times when social distancing is not possible.
- Providing adequate supplies for good hygiene, including clean and functional handwashing stations, soap, paper towels, and alcohol-based hand sanitizer.
- Students will have a personal supply box of materials; no shared materials.

### Routine Cleaning & Disinfection

- Increasing the cleaning and disinfection routine to multiple times per day, focusing on frequently touched objects and surfaces; disinfecting playground and gym equipment after use between each student group.
- Hiring a cleaning crew to clean and disinfect rooms nightly.
- Routine use of disinfection system to use for whole room sanitization.
- Routine use of whole room air purification systems (one in each classroom).

### Guidance on Reporting a Staff/Student Who Tests Positive For Covid-19

- (1) Immediately contact the Montgomery County Health Department,
- (2) Notify staff and families,
- (3) Close for 2-5 days while determining long term course which may include closure for 14 days or more,
- (4) Communicate with staff and parents regarding the confirmed case and exposure,
- (5) Clean and disinfect the child care facility as recommended by the CDC, and
- (6) Determine duration of program closure based on guidance from the Montgomery County Health Department.

Everyone potentially exposed to the person who tested positive for COVID-19 should monitor carefully for symptoms. Individuals who had close, prolonged contact with the person who tested positive should quarantine at home for 14 days after the last day of exposure.
